It is imperative that tuition payments be made on time. For your convenience, the tuition can be paid in full or divided into ten installments. The first payment is due on or before August 15th, with a payment each month through May.

Applicable late fees are assessed on the 20th of the month for which the charges are due.

If a student leaves the school during the course of the year, the billing will be as follows. The tuition is divided into quarters following the school calendar marking quarters. A student leaving the school at any time during a quarter, will be billed for that quarter.

As described by the board of directors, tuition contributes towards teacher salaries, rent, phone and insurance; however, does not cover all cost of education and maintaining the school.
